

13.1 Definitions

The following definitions are provided for your convenience. These should be used in accordance with the EIH Rule Book. This is not an exhaustive list.

"Abandonment" A fixture that is unable to be completed once a game

has commenced.

"Accumulated penalty

points"

The disciplinary points accumulated by a person or

team because of misconduct penalties.

"Appeal" An appeal against the decision of the Disciplinary

Committee within the context of the rules.

"BUIHA" British University Ice Hockey Association; the group

responsible for overseeing all university competition

based in the United Kingdom.

Any 'friendly' game duly sanctioned and authorised by "Challenge game"

the EIH Fixtures Secretary.

"Club" A club affiliated with EIH which is subject to

compliance with all EIH rules and regulations.

"Coach" An EIH certified coach who is registered with EIH for

the current season and who is subject to all EIH rules

and regulations. Levels include:

(a) Foundation Coach

(b) L1 Assistant Coach

(c) L2 Team Coach

(d) L3 Advanced Coach

"Competition" Any EIH sanctioned league, cup or playoff as defined

within the competitions structure.

"DBS" Completion of the disclosure and barring service

process.

"Disciplinary Proceedings relating to a disciplinary matter thathas Proceedings"

come before, or will come before, the Department of

Player Safety (DOPS) Committee.

"Dispensation" Special one-off allowance to facilitate player

movement between teams.

"Domestic event" A tournament, camp or exhibition held in England,

Wales.



"Department of Player Safety (DOPS)"

Department overseeing disciplinary procedings of the sport in England and Wales.

"Dual section registration"

Whereby a player registers for more than one section.

"Emergency transfer request"

A form of player movement permitted for players where a game could not be completed without the request.

"England Ice Hockey (EIH)"

Nationally recognised governing body for ice hockey in England and Wales.

"England National Team Programme (ENTP)"

The national talent pathway for players in England and Wales.

"Executive Committee"

The committee appointed to oversee the EIH, often commonly referred to as the "Board" and made up of Directors elected at the AGM or co-opted onto the committee.

"Failure to fulfil a fixture"

A fixture that is not played or completed.

"Fault"

Applies with regards to fulfilling fixtures. Fault includes but is not limited to:

- (a) Failure of a team to attend a fixture
- (b) Failure of a team to arrive in time to face off and complete the fixture within allotted ice time
- (c) Failure of a team to meet minimum bench requirements
- (d) Expulsion of coach during game resulting in failure of a team to meet minimum bench strength

"Game / match"

Any of the following:

- (a) a game in a competition
- (b) any ice hockey game played between two clubs

"Game misconduct penalty"

Penalty where a person is ejected and is sent to the team's dressing room.

"Gamesheet"

The official record of any EIH sanctioned game.

"Ice Hockey UK (IHUK)"

Internationally recognised governing body for ice hockey in the United Kingdom.



"In-House Rules"	Amendments to the IIHF Rules of the Game.

"International Ice Hockey Federation (IIHF)"

International governing body for ice hockey.

"JMC" Junior management committee responsible for junior

hockey.

"Junior hockey" Any team under the age of 18 and below.

"League games" Competitive games played as part of a sanctioned

EIH league structure.

"Major penalty" A penalty for a more severe infringing of the rules than

a minorpenalty and will lead the infringing player to

remain off the ice for five minutes of play.

"Management Group" The relevant league management group.

"Manager" An EIH certified manager who is registered with the

EIH for the current season and who is subject to all

EIH rules and regulations. Levels include:

(a) Assistant Manager

(b) Team Manager

(c) Advanced Manager (invitation only)

"Match penalty" Five-minute penalty and suspension until further

notice.

"Minor penalty" A team penalty that lasts for two minutes, and the

offending player is sent to the penalty box.

"Misconduct report" A report produced by the Disciplinary Secretary for the

Disciplinary Committee.

"Misconduct" Any personal act which has brought or may bring the

game of ice hockey into disrepute.

"NIHL Management" Committee responsible for NIHL hockey.

"NIHL" National Ice Hockey League



"No-fault"

Applies with regards to fulfilling fixtures. No-fault is applicable when:

- (a) Ice facility failure
- (b) Severe weather prevents travel (within a set of defined measures)
- (c) Medical emergency at venue / fixture
- (d) Unsafe rink conditions as defined in each section's rules

"Non-British trained player"

A player of any nationality who has not been registered and played for two seasons in a British junior (up to U18) club.

"Off-ice misconduct"

Instances occurring off-ice that require disciplinary action against and individual, Club or Team, including but not limited to breaches of the EIH Code of Conduct & Ethics and failure to fulfil a fixture.

"Off-Ice Official"

An EIH registered off-ice official who is subject to all EIH rules and regulations. A list of roles is available in section 11.0 Off-Ice Official Protocols.

"On-ice misconduct"

Instances occurring on-ice that require disciplinary action against an individual or team.

"Penalty / penalties"

The general term for any minor penalty, major penalty, match penalty, misconduct penalty, game misconduct penalty and any penalty called by a game referee based on offences described in the current

IIHF Official Rule Book, IIHF Case Book,

Coach/Manager Code of Conduct and the EIH In House Rules that incur an automatic suspension

"Penalty points fines system"

A sanction against a person as consequence of accumulating a requisite number of penalty points.

"Penalty points system"

The system for the ordering of penalty points

"Player"

An EIH registered player who is subject to all EIH

rules and regulations.

"Player/Coach"

A player who is dually registered with the EIH as a player and a coach.

"Playing up"

A form of player movement. Playing up can include playing in a higher age group or playing in a higher

division as defined in each section.



"Playoffs" Competition taking place after the end of the regular

season. Sometimes referred to as 'finals' or

'championship weekend'.

"Postponement" A fixture that is cancelled on the day of the game due

to no fault and is able to be rescheduled.

"Professional player" A player who holds a valid contract with a club and

where the majority of their income derives from the

sport of ice hockey.

"Recreational hockey

(Rec)"

Non-competitive hockey regulated by the Recreational

Section of the EIH.

"Referees" Match officials (also known as On-Ice Officials)

assigned by IHUK Referee section.

"Regular season" The period beginning on the day of the first scheduled

match in a competition and immediately after the completion of the last scheduled match of the

competition.

"Rules of the Game" The rules of ice hockey as published by the IIHF.

"Scottish Ice Hockey

(SIH)"

Nationally recognised governing body for ice hockey

in Scotland.

"Senior hockey" All hockey not limited by a maximum age group.

"Showcase Programme" Part of the EIH performance pathway for junior

players in England and Wales.

"SNL" Scottish National League

"Team list" A list of EIH registered players, coaches and off-ice

officials produced for any EIH sanctioned game. May

also be referred to as a team sheet.

"Team" A team within a parent Club registered to play in a

specific EIH league.

"Terms of Reference" The terms and conditions signed by any EIH

committee setting out the operation and governance

of said committee.

"To be arranged (TBA) A fixture that is awaiting rescheduling.

"Transfer" A player transfer between clubs or teams with

permission from both the releasing team and the team

to which they are transferring.



"WNIHL Management" Committee responsible for WNIHL hockey.

"WNIHL" Women's National Ice Hockey League
